OT Functions:

- Administers occupational therapy procedures and modalities for the purpose of achieving program objectives.
- Assesses students' fine and gross motor skills and functional abilities (e.g. perceptual-motor, hand functions, motor coordination, sensory development, muscle strength, etc.) for the purpose of determining their deficits and developing recommendations.
- Consults with teachers, parents, other personnel and/or outside professionals for the purpose of providing requested information, developing plans for services, making recommendations and/or coordinating occupational therapy services with those of other disciplines.
- Performs site visits at multiple work sites for the purpose of providing direct therapy interventions and assistance as required.
- Provides direct occupational therapy service for the purpose of developing students daily living skills in compliance with established goals and objectives.
- Screens students for the purpose of determining the need for further individualized assessment.
